1. Call to Order

Chairman DiMarco called the meeting to order at 3:00 P.M.

2. Roll Call

Roll call was taken, and a quorum of four was established.

3. Approval of Agenda

Mr. Berry moved to approve the Agenda. Second by Mr. Browne. Carried unanimously 4 - 0.

4. Approval of Minutes

Mr. Enderle moved to approve the minutes of the October 18, 2022, of the Public Transit Advisory Committee meeting as presented. Second by Mr. Browne. Carried unanimously 4 - 0.

Ms. Samek joined the meeting at 3:05 pm and a quorum of five was present.

5. Committee Action

a. 5310,5311,5339 Grant Applications

Mr. DeLeon presented the Executive Summary “Grant Application for 5310, 5311, and 5339” for submission of applications to the Florida Department of Transportation (FDOT). The Board of County Commissioners (BCC) must approve grant application submissions.

5310

The 5310-capital grant request in FY24 supports Collier Area Transit (CAT) System to purchase replacement vehicles to support the paratransit service.

- Funding in the amount of \$626,748.00 will be used to purchase four (4) replacement paratransit vehicles, radios and customization of various components that have met their useful life.
- The capital grant includes an 80% Federal Share (\$501,396.00), a State Match of (\$62,672.00) and a Local Match of (\$62,680.00).
- Replacement vehicles will not increase overall paratransit fleet inventory.
- The acquisition will provide for ongoing transportation services to the elderly and disable resident of the County.

5311

The 5311-capital grant request in FY24 supports the Collier Area Transit (CAT) System to purchase a replacement vehicle to support fixed route service.

- The capital grant funding in the amount of \$621,763.00 will be used to purchase one (1) thirty-five (35) foot fixed route bus to replace an existing vehicle that has met its useful life.
- The capital grant includes an 80% Federal Share (\$497,410.00), and a 20% Local Match (\$124,353.00).
- Funds received for FY23 were applied to Operating Expenses.

5339

The 5339-capital grant in FY24 supports the Collier Area Transit (CAT) System to purchase a replacement vehicle to support fixed route service in rural areas.

- The capital grant funding in the amount of \$621,763.00 will be used to purchase one (1) thirty-five (35) foot fixed route bus to replace an existing bus that has met its useful life.
- The capital grant includes an 80% Federal share (\$497,410.00) with a 20% State Match (\$124,353.00).

Mr. DeLeon noted the report includes a copy of the Grant Applications which will be submitted to the Board of County Commissioners for approval to submit them to the Florida Department of Transportation (FDOT).

The Committee discussed:

- Retired buses are sold by a County assigned auctioneer. Paratransit buses generate a greater profit.
- Proceeds from the auction are reinvested to offset local government match requirements.
- Auction revenue exceeding \$10,000.00 is returned to the Federal Transit Administration (FTA).
- Grant funds are utilized annually.

Vice-Chair Berry motioned to endorse the submittal of Grant Applications 5310, 5311 Rural, and 5339 Rural in the amount of \$1,870,274.00 to the Board of County Commissioners (BCC) for approval and submission to the Florida Department of Transportation (FDOT). Seconded by Mr. Enderle. Carried unanimously 5 – 0.

b. Vice-Chair Election Reconsideration

Ms. Arnold presented an Executive Summary “*Reconsideration for Vice-Chair Election*” noting in accordance with the Public Transit Advisory Committee (PTAC) Committee By-Laws, the election process must allow for all interested parties for a position to be considered before a vote is taken. A member must be present at the meeting to be nominated for a position.

Past Vice-Chair Peter Berry is interested in continuing to serve but was not offered consideration prior to the vote on October 18, 2022. Both Mr. Berry and Ms. Samek should be considered for the position.

Recommendation

PTAC should reconsider the Vice Chair Election held on October 18, 2022, to provide for consideration all interested members eligible for the position.

Mr. Enderle moved to reconsider the motion for the Vice Chair approved at a previous meeting. Seconded by Chair DiMarco. Motion carried 5 – 0.

Ms. Samek withdrew from consideration for the position.

Chair DiMarco nominated Peter Berry for the position of Vice Chair of the Public Transit Advisory Committee for one year, or until a successor is appointed. Seconded by Ms. Samek. Carried unanimously 5 -0. Mr. Berry assumed Vice Chair.

6. Reports and Presentations

Ms. Arnold commended Staff for their outstanding performance during Hurricane Ian, including operational functions entailing special transportation and accessibility and maintenance of shelters.

Committee members also recognized and thanked Staff for their exceptional contribution.

7. Member Comments

Ms. Samek queried regarding PTNE service route plans to the Paradise Coast Sports Complex just off Route 951 (Collier Boulevard). Staff noted:

- Route 19 offers service to the area with a STOP on Collier Blvd. in front of the park.
- SnowFest will be held at the Sports Park this year and CAT will be providing shuttle service between the Sports Park and Golden Gate Community Center.
- A bus stop is installed within the complex but is not yet activated on a route.
- Additional transportation implementation to meet the complexes needs is under consideration.

Staff noted:

- PTNE recently provided transportation services in coordination with emergency services for the DSNAP event held at the Paradise Sprots Complex to help mitigate parking congestion.

8. Public Comments

Staff reported Grant Applications are developed based on needs identified by the PTNE Division.

Item 6a
Seasonal Schedule Change Performance

Objective:

To update the Committee on the impacts the recent schedule change had on Ridership and On-time Performance.

Considerations:

On November 27, 2022, CAT implemented service changes that were designed to retain and promote ridership and improve the systems on-time performance. Several changes were recommended from the Comprehensive Operations Analysis (COA).

The changes included merging Routes 20 and 26 into a single Route 20 and Routes 19 and 28 into a single Route 19, covering relatively the same service areas. Route 25 has been modified to go north and south on US 41 rather than Goodlette-Frank Rd. The path for Route 21 has changed to now service the Walmart at Collier Blvd and Davis Blvd intersection.

To evaluate the effectiveness of the changes, staff has analyzed ridership and on-time performance data from the system compared to previous years. The results of the analysis will be presented at the meeting.

After implementation, staff received feedback from many members of the community and regarding the impacts of the Route 21 changes. As a result, staff is recommending adding a mid-day loop to the Route 21 starting at the US41 Walmart at 3:00 p.m. to provide connection for shift workers on Marco Island. This change will go into effect at the beginning of February.



CATConnect Select

Objective:

To update the Committee on the new On-Demand Paratransit pilot project offered through CAT Connect Select.

Considerations:

On December 13, 2022, CAT launched an On-Demand Paratransit service, CATConnect Select, that allows riders to make same day bookings with pick-ups within a 30-minute window. This program was designed to provide more flexibility for our riders, allowing them to book trips in the same day for situations that may not have been originally planned for.

The service runs from 6:00 a.m. to 10:00 p.m., 7 days a week. The customer only pays \$4 for any trip under 8 miles. Trips farther than 8 miles are priced at \$2.50 per mile and customers are told the cost when booking the trip. Customers can call in or create an online booking to reserve their trips. A mobile app will be available soon for the passengers to book their trips.

Staff will present reporting info from the first month of operation and discuss our findings with the committee.


